 - 6.4. Acknowledgement was given to our Treaty 7 neighbours and going forward an effort will be made to include First Nations in our actions and activities
 - 6.5. The appreciation picnic was held

 - 6.7.1. Congratulations to the people who put on events during the pandemic (following pandemic requirements)

Q: Any actions regarding wildlife collisions on the ring road?

A: Wildlife fencing was not installed during the project and unlikely to be install until next year. There is GIS being used to plot collisions and an Alberta Transportation and Citizen Science project monitoring wildlife passages but show little use at this time

Q: Any updates on the response from the Province on the spills to the beaver ponds? A: Still under investigation. There is hope for Alberta Transportation to have to have public pressure to improve standards for erosion control and environmental standards for future construction.
